HOW TO APPLY FOR A MARRIAGE SEARCH

Complete the Application Form and lodge **WITH THE REQUIRED IDENTIFICATION.**

BY POST – send the form with your cheque, money order or credit card details to: Registry of Births, Deaths and Marriages, GPO Box 198, Hobart, Tasmania, 7001. **Overseas applicants MUST** pay by credit card or bank draft in Australian dollars.

IN PERSON – you may apply and pay for your certificate at any *Service Tasmania* Shop listed below:

PROCESSING TIME FOR APPLICATIONS

STANDARD – applications for non urgent searches will be processed within 5 working days from when the form is received at the Registry of Births, Deaths and Marriages. Please note, processing time may increase during peak periods. The result of the search will be mailed directly to the applicant. In some circumstances a different postal address will be accepted.

URGENT – applications for urgent searches (extra fee payable) will be processed the same day. For current fees and further details please ring (03) 6233 3793, or check the website – www.justice.tas.gov.au/bdm
Please note personal cheques are not accepted for the priority service.

WHO CAN APPLY FOR A SEARCH

Marriage searches are only available to one of the parties involved in the marriage or a child of both parents. If the applicant is not the registered person the Registry of Births, Deaths and Marriages may request further evidence of relationship. If you fall into a category other than those stated contact the Registry of Births, Deaths and Marriages for further information prior to making application. Family History applications are accepted from any person if the marriage was more than 75 years ago and the married parties are no longer living. HOW TO PROVE YOUR IDENTITY

When lodging the application for search you must prove your identity. If you are applying by post, send photocopies of your identification with the application. See above for acceptable types of identification.

PRIVACY NOTES

In line with the *Personal Information Protection Act 2004*, the Registry of Births, Deaths and Marriages is collecting this information so that it can determine your eligibility to obtain the requested certificate and to prevent fraud. If you do not provide all of the information requested, particularly that relating to the reason the document is required and your relationship to the registered person, then you may not be provided with a copy of the certificate. Your personal information may be disclosed to law enforcement agencies, courts and other organisations authorised to collect it.
