INTRODUCTION

Master Builders' Association of Tasmania Inc. (Master Builders Tasmania) was established in 1891 and is a registered Union of Employers under state and federal laws.

Master Builders Tasmania (MBT) has thirteen (13) employees and twenty one (21) apprentices employed through its registered Group Training Organisation. MBT represents 95% of all commercially orientated builders. Around forty five percent of all residential construction undertaken by licensed builders in the State is undertaken by MBT members.

In addition, the MBT is widely represented on many industry and Government bodies and provides on-going assistance to both industry participants and members of the public on all matters related to the building and construction industry.

Draft Land Use Planning and Approvals (Miscellaneous Amendments) Bill 2018

Master Builders Tasmania (MBT) supports the thrust of the administrative changes to the Land Use Planning and Approvals Act 1993 (LUPA Act) and the Tasmanian Planning Commission Act 1997 (TPC Act).

As the Government would be aware, MBT has been involved previously with the TCP with its former Executive Director, Michael Kerschbaum, an invited representative on the Planning Reform Taskforce.

The scope of the proposed legislative changes for both the LUPA Act and the TPC Act will see an improved and productive management of processes and will remove unnecessary steps in a number of areas.

Changes to the LUPA Act

- 1. Streamlining the draft LPS approval process
 - a) Considering the LPS Criteria
 - The "as far as practicable" determination for Local Provisions Schedules and the reduction in time in approval processes is supported by MBT.
 - b) Issuing a 'LPS criteria outstanding issues notice'
 - The fast tracking of draft LPSs for pubic exhibition is supported.
 - c) Removing an administrative step in the draft LPS exhibition process Supported.
- 2. Aligning the SPPs with other planning reforms
 - Supported.
- 3. Notice to 'relevant agencies'

All parties who are affected by, or have an interest in, draft amendments to a planning scheme should be advised and ensure they are provided with the opportunity to make representation on those draft amendments. Supported.

Changes to the Tasmanian Planning Commission Act 1997

Minor change, more an administrative process, but need to ensure that changes do not alter the meaning of a decision made, merely a clarification or correction of a clerical error. Supported.
