Response from Department of Justice:

The Department uses a range of internal measures to cover vacancies. The measures employed include:

- additional hours;
- varying duties;
- casual and fixed term short term cover; and
- careful consideration to the way in which work is completed.

These actions are consistent with the Head of Agency's function to ensure that the Agency is operated as effectively and economically as is practicable.

Consequently, due to complexity and continuous actions employed, we are unable to provide a quantifiable figure.

The Department is able to use one measure of "vacancy" by identifying positions advertised, but this does not mean that the position is necessarily unoccupied at the time.

As of 25 January 2023, the Department currently has 11 vacancies advertised online at <u>www.jobs.tas.gov.au</u>. I note that in addition to these positions, there are three advertisements for fixed-term registers and one for multiple positions as a Correctional Officer – please see attachment B "Departmental Vacancies".
